- 2. Pledge of Allegiance
- **3. Minutes –** Trina made motion approve. Mick second. Passed unanimously.
- **4. Treasurers Report** February statement balance of \$3,200.34. Pending balance after recent payments of insurance and CE bill, as well as receipts for membership dues and George Voelker Memorial Gifts, is \$2,923.60. Trina made a motion to accept. Nola second. Passed unanimously.
